

RUTH ANN HACKLER SCHOLARSHIP APPLICATION

The Alumni of St. John Memorial High School, Class of 1953 established a \$500 scholarship in honor of Mrs. Ruth Ann Hackler, a former business teacher at the school, in the early 1950s. St. John Memorial High School later became Olathe High School.

This one-year scholarship will be awarded to one graduating senior from Olathe North High School who meets the following requirements:

- The applicant must be enrolled at Olathe North High School as a senior, planning to graduate spring, 2012.
- The applicant must have taken at least one business class at Olathe North. Classes include but are not limited to: Marketing, Personal Finance, Entrepreneurship, Management, Introduction to Law, Accounting, or Keyboarding.
- The applicant must demonstrate financial need.

This scholarship will be paid in one disbursement of \$500.

This scholarship is administered by the Olathe Public Schools Foundation. The scholarship recipient must provide proof of enrollment at an educational institution prior to scholarship disbursements. Scholarship disbursements are made directly to the educational institution.

Applicants must fully complete the following application and required short essays and submit the packet to their school scholarship counselor by March 2, 2012. The scholarship will be presented at Senior Awards Night.

- Essay Question Answers
- Completed Personal Financial Statement
- Current copy of their transcript
